In table 1.1 it can be seen that in 2020 and 2021 for man experience a decrease of 1.02% and 0.17% for women experience increases of 2.48% and 0.39%. Average increase from 2018 until with 2022 for man by 0.31% and women of 0.76%. Reasons the generally related with ambition you have women , which is often connected with aspirations , targets, plans, and motivation For reach performance (Ermawati, 2016).

Based on the latest data from the Central Statistics Agency (BPS), percentage the poor population in March 2023 is by 9.36%, decreased compared to period previously (BPS, 2023). Amount recorded poor people amounting to 25.90 million people, with a poverty line per capita per month amounting to IDR 550,4581. Analysis poverty macro in Indonesia shows that factors like index development people, consumption, investment, and provincial minimum wages own influence significant to level poverty (Irwansyah et al., 2019). Other research emphasizes importance growth economy and aid proper social For increase Power buy society and reduce poverty.

Women are often placed in a vulnerable position in the labor market work, with access limited to the work that provides wages equivalent with colleagues man they . Research by Kabeer (2005) shows that poverty often related with inequality in chance employment and wages in various countries, limiting Woman in role conventional as worker No skilled or with less informal work support. Inequality in opportunity work deepen role double woman, because they often must fulfil demands outside work House while still operate role traditional as mother and caretaker House ladder. A number of research, such as that conducted by Sen (2001), shows that inequality in access to formal employment and education can become obstacle big for Woman For go out from circle poverty. In context here, woman often trapped in cycle difficult poverty For solved without exists intervention the right policy.

Informal work tends to be not enough stable, less regularly, and often not give guarantee social or security Work. The study by Chen and Carr (2001) shows that woman tend dominate informal sector, such as worker home or work everyday, which is often considered as low work status and less support in increase well-being economy they. Condition a job that doesn't definite and lacking guarantee social can worsen uncertainty economy family. Working woman in informal sector perhaps face more risk big related with lost work or disease, without adequate access to support finance or service health. Therefore that 's poverty No only influence role double woman in matter participation economy but also expanding to dimensions welfare and security social they.

Apart from aspects work, education also become factor key in understand How poverty can influence role double woman . Living woman in condition poverty often face limited access to quality education. The study by Duflo (2012) highlights importance education for empowerment women and reduce gender inequality. However, in many case, women in poor areas often do not capable access education tall or even education adequate basis . Inequality in access education create environment where women own limited skills and knowledge, which is then limit opportunity them in the energy market Work . This is not only influence role double woman in economy family but also brings impact period long to capacity they For contribute to development economic and social. Therefore that,



For overcome burden double here, girl workers in the Village Pancor apply some balancing strategies, such as share task with husband, children, or relatives, arrange time and priorities, take advantage network social, take paid leave or permission, as well pray and give thanks. This strategy No always it worked, but can help Woman worker For reduce stress and conflict that they experience. Study This recommend necessity awareness and participation husband in help Woman workers, as well support from government, society and institutions Work in give facilities and protection for Woman worker.

Study results from study (Nurpaiz et al., 2020) show that law a wife work outside House is OK, with condition He No ignore his task as a Mother. However conversely, if si wife neglect task mainly, then Islamic views on wife the is No can or haram. A number of encouraging factors wife work outside House such as factor economic, factors education, factors opportunities, and factors desire. A number of the impact caused by the wife work outside House such as happen divorce, neglected right husband and children, as well emergence conflict and disharmony in family. Several strategies carried out by the wife Work in look after family such as share task with husband, children, or relatives, arrange time and

priorities, take advantage network social, take paid leave or permission, as well pray and give thanks. This study recommend necessity awareness and participation husband in help wife work, as well support from government, society and institutions Work in give facilities and protection for wife Work. This study also suggests that wives Work choose suitable job with nature and ability women, as well avoid contradictory things with Islamic law, such as khalwat, ikhtilat, aurat, and usury.

# How role double woman inside family influence aspect economy?

Double role woman inside family own impact significant in aspects economy, creating dynamics stability influencing complex finance development family. Aspect economy This covers income, distribution work, and decisions finance together. Woman holding role double, that is as outside workers house and caretaker House stairs, often face challenge in reach balance between work and responsibilities answer House ladder. In terms of income, role double woman can give contribution positive to economy family with increase source income. However, p this is often the case too impact on available time and energy For work House ladder . In some case, income addition from work woman outside House can help fulfil need financial family, giving access more big to education and health, or even reduce pressure economy family.
